### **Traffic Matters** 2019/09

Cllr Hide updated the Council on the current position regarding the proposed bypass. The Parish Council had submitted its response to the consultation on Rutland County Council's draft Local Transport Plan (LTP), endorsed by County Councillor, James Lammie and a petition of 202 signatures, representing 91% of the electorate. The submission called for the need for a bypass to be stated unequivocally in the LTP, that it be set as a priority in the first 5 years of the Plan and that a commitment is made to undertake a feasibility study as soon as possible. Many individuals are also known to have written in to RCC as well as to Corby Borough Council regarding the West Corby development plans (4,500 new homes plus schools and commercial). RCC, following a meeting with Corby Borough Council has submitted a document identifying a number of issues that need to be resolved as a result of the West Corby development. The surrounding villages of Great Easton, Gretton, Horninghold, Stoke Dry, Seaton, Middleton, Thorpe, Uppingham and Hallaton, either directly support the call for a bypass or urge RCC to address the enormity of the impact of West Corby on the local road network. The County Council is now working on a revision to the LTP which is hoped to be issued at the end of March.

Welland Close Parking - Representation has been made to the Council that

despite letters to its residents asking that they park responsibly, the problem of congestion and restricted access still remains. The Council **agreed** to take photographic evidence which could be used to refer to either the fire brigade or to the County Council for assistance in resolving this issue.

Cllr Hide informed the Council that all CRAG documents including historic traffic data are currently being stored in the Village Hall. Cllr Hide **agreed** to look in to how much it would cost to scan these files so that they may be stored on a computer.

# 2018/1331/FUL Wentworth Cottage Demolition of Porch and Utility, Construction of Single Storey Extension

# Safety Review of Parish Assets 2019/12

Cllr Hide had carried out a safety review of parish assets. He stated that all other than the Pinfold Wall were in reasonable condition. A quote for £10,500 has been received to take down and rebuild the wall to make it safe. The Council acknowledged the historical value of the wall and the need to obtain further quotes. It **agreed** to look at options for funding it. Cllr Richmond will pursue.

#### Children's Play Park 2019/13

Cllr Hide updated the Council on the current position regarding the proposed children's play park. A project team has been formed to manage the design, contracting and installation of the playground, to seek grant funding opportunities and to undertake fundraising activities, the primary purpose being to lessen the impact of the increased precept. Grant applications have been lodged with both WREN and Mick George, the success of which will be made known in the latter half of March 2019.

Cllr Hide wished to thank local resident Becky for all her hard work fundraising in order to mitigate the precept – £481.56 has been raised since 1st January which will be held in the Parish Council bank account and ring-fenced.
