Cllr Bennett declared an interest in item 2023/67 (a).

There were no changes to the Member's Register of Interests

Co-option of New Councillor

There were no candidates put forward for co-option at this time.

2023/61

The Casual Vacancy will continue to be advertised.

Open Forum and Exchange of Information 2023/62

Cllr Bennett advised of a report from a resident regarding a metal pole protruding out of footpath on Main Street. This had been reported to RCC and a cone has been placed over it whilst it is awaiting repair. Cllr Brown will follow this up.

Cllr Bennett also advised that the public footpath from Mill Lane to Burgess Row is very overgrown and impassable. This has been reported to RCC but as yet nothing has been done. County Cllr Brown will follow up too.

Cllr Parker informed the Council that she had offered to replace the signs around the churchyard and asked the Council to consider whether there any more signs needed doing at the same time.

Minutes **2023/63** 

The minutes of the Parish Council Meeting held on 13<sup>th</sup> July 2023 were approved as a true record of the meeting and duly signed by the Chair.

Proposed Cllr Bennett Seconded Cllr Parker

Matters Arising 2023/64 There were no matters arising not covered elsewhere on the agenda.

Highways and Rights of Way 2023/65 Following correspondence from a local resident on the possibility of preserving the old brick bridge on the A6003 at the southern entrance to the village, a discussion took place on whether this bridge could be listed and whether there was any advantage of doing this. The Council **agreed** that as this was a complicated process it was not in a position to progress this at the current time.

Cllr Bennett reported from the recent visit she had attended with MP Alicia Kearns to look at the various Highways related issues in the village. A number of points of action were taken away by Ms Kearns including writing to the HGV companies travelling regularly through the village and to request that the width of road be measured/investigated as currently the width of the road at Caldecott negates that A6003 from being an A road. Cllr Bennett advised that she had recently requested feedback but as yet none had been forthcoming. Cllr Brown will chase too.

It was **agreed** to write to Uppingham Town Council, seeking support and to advise of the visit from MP Alicia Kearns and that if any of the actions were progressed, this may be of benefit to Uppingham in terms of volume of HGVs.

It was noted again that to repair the flagpole would be cost prohibitive, therefore the Council will look at options to purchase a new one at the next meeting. Cllr Hook will liaise with the Village Hall Committee regarding the re-siting of the noticeboard.

- c) Changes to RCC Mowing Contract Cllr Bennett had met with a contractor and a quote had been provided to mow both the playing field and the RCC owned land. It was **agreed** to obtain alternative quotes for the parish mowing and to consider these along with the grant and service provided by RCC when setting next year's budget at the next meeting.
- d) Allotments Cllr Parker had circulated a draft letter to allotment holders explaining the benefits of joining the National Allotment Society. The Council agreed to send both this and an updated tenancy agreement with the rent bills at the end of the year. Cllr Parker will draft a new tenancy agreement for review at the next meeting. It was noted that Cllr MacDermott had met with ABC Gardens to look at marking out the individual plots with a concrete marker and to mow the communal areas bi-annually. The Clerk will forward a map of the allotments
