Attention was drawn to several wooden bollards on the Greens which are either missing or damaged. The Council will obtain quotations for their replacement or repair and will consider the option of installing small concrete posts as a more durable alternative to prevent future JM deterioration.

The Council acknowledged the recent improvements to Mill Garage and agreed to write to the owner expressing its appreciation on behalf of the community.

Highways and **Rights of Way** 2025/46

- a) Update on Community Speedwatch The Council was unable to take advantage of the vacancy in the upcoming scheme as only two volunteers were available at such short notice. Cllr McCole advised that 15 to 20 volunteers were needed to cover two sessions a day over a two-week period. The Council hoped to take part next year when there was more notice to gather support.
- b) A6003 HGV signage In the absence of Cllr MacDermott this item was deferred to the next meeting.
- c) Follow up from Police Commissioner Visit The Council had written to thank the Police Commissioner for his recent visit. This had been copied to RCC Head of Highways and Ms Kearns MP.

A response had been received from the police commissioner agreeing with the Council's suggestion to reduce the speed limit through the village and RCC Cllr Wise, Portfolio Holder for Transport, Environment and Communities, will hopefully attend the next meeting. The Council noted the below response sent from the MP's office from RCC Head of Highways and Transport:

"Rutland County Council has approved a refresh of its Local Transport Plan (LTP) at the Cabinet meeting on the 8th April 2025. This will ensure that the Council's LTP will align with current national and local planning, transport, and environmental policies. We are currently in the final stages of commissioning with our delivery partner to work on the refresh of the

LTP. This refresh will include consultation with stakeholders of which Caldecott PC will be one.

Within the 2019 LTP4 in PGS2 – Assess the capacity of our network, a relief road for Caldecott was specifically mentioned both with regards to historic funding and with regards to a plan moving forward in respect of a feasibility study. Whilst this may still be the case the refresh of the LTP will need to consider a holistic view across the whole of the Council's network ensuring that priorities are identified in this specific area (PGS2). As you will appreciate much has changed since 2019 and whilst this refresh will bring the LTP in line with current policies it will still be impacted by the spending review currently being undertaken by central government"

Meanwhile, the Council decided to organise a residents' meeting to assess community support and provide an opportunity for villagers to propose suggestions to address congestion, excessive speed, and the presence of heavy vehicles.

Parish Assets 2025/47

Routine Inspection – Cllr Hook had carried out the routine check of parish assets. He had observed a missing cover on the rope on the flagpole and some large plants growing out of the mortar joints in the Pinfold Wall, which could potentially cause structural damage if left untreated. Local gardener Joe McCole very kindly offered to deal with this by spraying it off at no cost to the Council.

Play Area – There was nothing to report on this area.

Allotments – The Clerk updated the Council on the current position with the allotments. Plot one is still available and will be offered to prospective tenants at no cost for the remainder of this year.
